## Future of Oil Prices

I found a YouTube video that I thought would answer some of our industries question about oil prices, the future of hydrocarbons and the growth of electric cars. Eric Nuttall, Senior Portfolio Manager at Ninepoint Partners talks with Financial Post's (a Canadian Financial show) Laryson Harapyn about some of the common questions we have in our industry after the hit it took in 2020.

The first question at hand was should we expect a more normalized demand for oil because of the rollout of the COVID-19 vaccine. Nuttall referenced Japan as one country who is already seeing normalization in the use of oil and gas. He thinks that the USA and Canada will not see complete normalization until 2022 or 2023. However, because many of us have been on lockdown we are anxious to start traveling again and that should help tremendously.

Harapyn asked Nuttall's thoughts on headlines like the "End of Oil". His opinion is that hydrocarbons should continue to grow for the next 10-15 years. The population is growing by 2 Billion and lots of those people are in countries where buying a \$100,000 Tesla is not an option and probably never will be. He also said that some countries still use cow dung as a source of energy. Nuttall went on to say It is very hard to predict if we have reached peak demand.

A concern for all of us in this industry is the recently elected President and his administration. Nuttall agreed that with President Biden at the helm it is probably a "net-negative" for US and Canadian oil producers. He said it will be harder to get permits on federal land and Keystone XL will be shut down (and it has been).

Lastly Harapyn asked about the growth of electric cars. He referenced back to the countries that could not afford for the average person to buy electric cars but in the US he doesn't believe there will be a hyper adoption rate of this in the next few decades. His bases for this are for the number of gas-powered cars that are set to be produced. Also, at this point we would use 85% of our lithium reserves if we went total electric.

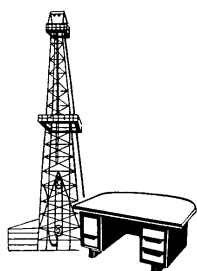

## Oklahoma Real ID Need to Know By Michelle Burgard

During our January membership meeting we all talked about the Oklahoma Real ID and quickly learned we had all heard different facts about it. So, I thought I would investigate this and find out for sure what you need to obtain the new Real ID and find out what else you need to know.

I found out the deadline is October 1, 2021 and that you can still use your current Drivers License until then to fly domestically or enter federal facilities. I have included the document list of what you need to take when you go to get your Oklahoma Real ID. I also found out from talking to others that have done this that your license will be mailed to you within 7 business days. I was also told you will get to keep your current license for use until the Real ID arrives.

### Do I have to get a REAL ID-compliant card?

No. Oklahoma will allow individuals to choose between a REAL ID driver's license/ID card and a non-compliant driver's license/ID card. If a person chooses to get a non-compliant license or card, they will need to present alternative forms of identification, such as a U.S. passport, accepted by the agency or facility in question. Some agencies or facilities may have additional requirements to accommodate individuals lacking the correct ID documents.

### What is REAL ID?

REAL ID is a coordinated effort by the states and the federal government to improve the reliability and accuracy of state-issued identification documents, with the intent of inhibiting terrorists' ability to evade detection by using fraudulent identification.

The REAL ID Act of 2005 established minimum standards for the production and issuance of state-issued driver's licenses and identification cards and authorized grants to assist states in implementing the requirements. The Act prohibited federal agencies from accepting driver's licenses and ID cards from states unless DHS standards were met. Official uses included accessing federal facilities, entering nuclear power plants, and boarding federally regulated commercial aircraft. In 2007, the Oklahoma Legislature passed a law prohibiting DPS from implementing this REAL ID Act, specifically prohibiting DPS from implementing any provisions that would comply with this federal law. In 2017, HB1845 was passed by legislators, allowing DPS to come into compliance with the REAL ID Act of 2005.

I found these questions and more at [REAL ID FAQs \(oklahoma.gov\)](https://oklahoma.gov/realid/faq). I encourage all of you to look at this site for more questions and answers. The cost of the Real ID is 25.00. Also know that not all tag agencies are issuing the Real ID and most that are have you make an appointment mostly online. Currently I have an appointment set up for February 19<sup>th</sup> and I'll be glad to answer any questions you have after that appointment. Good Luck on making the choice that is right for you!

Oklahoma will begin issuing **REAL ID** on July 1, 2020 at select locations

You will need to provide proof of identity/lawful presence in the U.S. The document must be an original or a certified copy. Notarized documents are not accepted. Please select **one (1)** document from the list below:

- ☐ State-issued Birth Certificate
- ☐ Unexpired U.S. Passport
- ☐ Unexpired Permanent Resident Card
- ☐ Unexpired Employment Authorization Card
- ☐ Valid, unexpired foreign passport with a valid, unexpired U.S. visa and valid I-94 issued by DHS
- ☐ Naturalization Certificate
- ☐ Consular Report of Birth Abroad
- ☐ Certificate of Citizenship

**NOTE:** If your name is different from the document which is presented from Section One (1) above (due to adoption, marriage, divorce, court-ordered name change), or is not the same on all your documents, you must provide additional documents with legal proof of every name change. Each document must be an original or a certified copy. Notarized documents are not accepted. Please bring **one (1)** document from the list below for **every name change** from your Section One document to your current name:

- ☐ An official government-issued marriage certificate/license
- ☐ Court-ordered or legal name change document(s)
- ☐ Court-ordered divorce decree
- ☐ A government-issued death certificate of spouse which includes a connection to your current full legal name
- ☐ Legal adoption paperwork

You must provide proof of your Social Security number. The document must be an original or a certified copy. Notarized documents are not accepted. Please select **one (1)** document from the list below:







- ☐ Current W-2 or 1099 showing full Social Security number
- ☐ Current pay stub showing full Social Security number
- ☐ Social Security Card
- ☐ Non-SSA 1099 form

## 3.

You must provide two (2) proofs of your current Oklahoma address. Both your name and current residential address must appear on the documents. Junk mail or personal letters will not be accepted. Forwarded mail will not be accepted. Please bring **two (2)** documents from the list below:

- ☐ Copy of previous year's federal or Oklahoma tax return filing
- ☐ Utility bill (electric, telephone [home or cell], water, sewer, cable, satellite, heating oil or propane provider)
- ☐ Installment loan contract or statement from a bank or other financial institution (payday loan company documents are not accepted)
